International Conference „Local Production and Access to Medicines“

Harvinder Singh ALAG graduated from the University of Bombay in Mathematics. He has worked in pharmaceutical industry starting as a Medical Representative in Glaxo India in the year 1988. During his tenure with Glaxo, he did his Diploma Course in Management Studies. Thereafter, he joined the Zenufa group, then Mimco Pharma, in Congo in 1994 as a Branch Manager where he was mainly responsible for administrative, sales and marketing activities. Moving up within the ranks of the company he was appointed as the CEO and overall in-charge of the company operations in Tanzania. Zenufa owns a modern GMP compliant pharmaceutical manufacturing facility in Dar-es-salaam, that was commissioned in July 2007. One of Zenufa's objectives is to achieve WHO prequalification for two products within the next years.

Astrid BERNER-RODOREDA (MA Univ. of London) is the Advisor for HIV and AIDS at Bread for the World (BfdW), a German church-based development agency where she has been working for more than 17 years. She was Head of the Central and Southern Africa Desk at BfdW until 2003 when she began to specialize on HIV and AIDS. An anthropologist by training, she increasingly became involved in matters regarding anti-retroviral treatment, as she feels strongly that prevention and treatment go together and that access to treatment needs to be improved in order to realize the right to live and health for People living with HIV and AIDS (PLWH). Astrid Berner-Rodoreda has been involved in pharmaceutical lobby and advocacy work for many years. She has been instrumental in setting up the Pharma Working Group at Action against AIDS and has taken part in talks with individual pharmaceutical companies at numerous occasions.

Sudip CHAUDHURI is Professor of Economics at the Indian Institute of Management Calcutta. He joined the faculty of IIM Calcutta in 1984 after obtaining PhD from the Jawaharlal Nehru University, New Delhi. Mr. Chaudhuri has published widely including a book on WTO and India's Pharmaceuticals Industry. He has done commissioned studies for various organizations including the World Health Organization, Geneva; United Nations Development Programme, New York; United Nations Industrial Development Organization, Vienna, Reserve Bank of India and the Government of India.

She is the Director of Pharmaceutical Services and also the Chief Pharmacist of Ghana Ministry of Health. Mrs. Gyansa-Lutterodt obtained her B Pharm degree at the University of Science and Technology Kumasi Ghana, a post-graduate Certificate in Health Management and also an MA in Health Management Planning and Policy at the University of Leeds, UK. As one of the drafters of Ghana's Health Policy 2007, she believes in evidence-based policy decision making and of constant exploration of ways to improve the processes that allow health policies to move into practice that provides sustainable outcomes especially for the most vulnerable. As Director of Pharmaceutical Services and also as an advocate for quality local production of pharmaceuticals her focus is to ensure that responsible access to medicines is promoted globally.
